Abstract: The Savery, Scheetz, & Gilmour Collection comprises 834 architectural drawings

and 65 photoprints documenting 53 projects 1909 to 1971. The collection includes the work of the architectural firm of Savery, Scheetz & Gilmour, and work of the predecessor firms, Savery, Scheetz & Savery, Architects and Savery & Scheetz, Architects, and of the successor firm, William Cramp Scheetz, Jr., Architect.

Biographical/Historical Sketch

The firm of Savery, Scheetz & Gilmour traced its beginnings to the practice of Addison Hutton (1834-1916), established in 1870, but the name of the firm was derived from the association of William Cramp Scheetz (1872-1945) and Albert H. Savery (1871-1939), first formed in 1899. By 1904, Hutton formed a partnership with his nephews Albert and Addison Hutton Savery (ca. 1872-1931) in a firm called Savery, Scheetz & Savery. By 1915, the name had been shortened to Savery & Scheetz. In 1927, Douglas Wilkinson Gilmour (1902-1969) joined the firm and was made a partner in 1937. That same year, William Cramp Scheetz, Jr. (1911-1996) joined the practice. It is not certain when he was made a full partner, but this may have taken place around the time of the elder Scheetz's death in 1945, since he joined the national A.I.A. in 1946. Savery, Scheetz & Gilmour continued until 1958, when Douglas Gilmour left to establish a separate firm with Fred Fretz Martin. William Cramp Scheetz remained in practice until he retired in 1980.

Scope and Content Note

The Savery, Scheetz, & Gilmour Collection comprises 834 architectural drawings (790 original drawings and 44 photomechanical prints) and 65 photographs documenting 53 projects 1909 to 1971. It includes the work of the architectural firm of Savery, Scheetz & Gilmour, the predecessor firms, Savery, Scheetz & Savery, Architects and Savery & Scheetz, Architects, and its successor, William Cramp Scheetz, Jr., Architect. Residential projects predominate, primarily located in the greater Philadelphia region. The collection also includes institutional, ecclesiastical, commercial and military projects.

The Savery, Scheetz, & Gilmour collection is arranged in two series:

Series I comprises architectural drawings, photomechanical prints and oversized photographic prints. Series II comprises smaller photographic prints.
